Sin duda, la bibliografía existente hoy sobre la corriente desconstructora es abundante (sobre todo en inglés y en francés); no obstante, son relativamente escasos los estudios dedicados a la aplicación práctica de la desconstrucción a obras literarias concretas. La relación bibliográfica que sigue no aspira, evidentemente, a ser exhaustiva, pero sí a dar una idea general del estado de la cuestión y proporcionar información sobre estudios que pueden ser de gran ayuda para una aplicación práctica.
